INSTALLATION

Note - If this luminaire is being used in conjunction with an external PIR or sensor, please confirm with the manufacturer of the sensors that they are compatible with LED luminaires

- Provide power to the required point of installation
- Remove the diffuser by inserting a small plastic flat-headed tool into the frame (see Fig. 1)



- Using the luminaire as a template, mark the location for, and drill the fixing holes ensuring not to infringe with any gas/water pipes or electrical cables
- · Ensuring correct polarity is observed, carefully wire as shown in Fig. 2



- · Secure the mains cable under the cable clamp
- Re-fit the diffuser ensuring that the earth fly-lead is connected, and the plastic strings are attached to the body and diffuser
- · Switch on and check for correct operation
